### **Observation on Open Ended Responses (2022-23):**

- 1. Two percentage of the student's not happy with the availability of the teaching learning facilities in the institution.
- 2. Five percent of the Students needed ICT facilities in the classroom and seminar hall should be improved.
- 3. Four percent of the Students not satisfied with laboratory and adequate facilities of the necessary equipments for training.
- 4. Three percent of the Students are suggested to maintain and updated the ICT facilities.
- 5. Three percent of the Students are suggested to maintain and updated the library regularly.
- 6. Eight percent of the students mentioned hostel maintenance and facilities not hygienic and in effective way.
- 7. Eight percent of the students are seeking maintenance of canteen and mess and facilities are not in hygienic and effective way.
- 8. Ten percent of the students felt that indoor and outdoor facilities must maintain and updated.
- 9. Seven percent of the students conveyed the transportation and parking facilities not maintained and updated regularly.
